WHEREAS, the City Of Vernon, Washington County, Florida, Florida, on the 25th day of September 2023, held the public hearing to finalize the millage rate as required by Florida Statute 200.065; and

WHEREAS the gross taxable value for operating purposes not exempt from taxation within Washington County, Florida, has been certified by the Washington County Property Appraiser to the City of Vernon as \$25,971,920
